KC&BO REC WORLD SERIES PROTOCOLS:

Eligibility Requirements | Tournament Details | Team Formation | Registration | Payment | Roster Building | Communication | Rules

ELIGIBILITY REQUIREMENTS:

- **Clarifying Eligibility Statement:**

The KC&BO REC World Series is NOT accepting ANY ALL STAR TEAMS; ANY PREMIER/ADVANCED REC TEAMS, or ANY SELECT TEAMS. Newly formed All Star Teams, and Premier/Advanced Rec Teams, should be encouraged by their leagues to play in the All Star Tournaments being hosted in Colleyville, Grapevine, Flower Mound, etc., and those teams are NOT eligible to compete in this event.

- The eligible player pool is from the Spring 2026 Season recreational teams. No players that played on Premier/Advanced Rec teams during the spring recreational interlock season are eligible for the REC WS. (i.e., Premier players may not play in the REC WS.)

- Home Associations will be responsible to ensure the rosters of the recreational teams entering the REC World Series are comprised only of eligible players from their Spring 2026 Recreational Season. The REC World Series is ONLY OPEN to associations participating either in TEBA / DFW INTERLOCK or other teams/leagues VETTED and APPROVED by the KC&BO REC World Series COMMITTEE – we do this to ensure a level playing field for the recreational teams. We respectfully REQUIRE each league have board level sign-off on team rosters for the REC World Series.

TOURNAMENT DETAILS:

- Tournament Dates: May 29th – 31st (3-days, including Opening Day which is Friday, the 29th)
- Age Groups:
 - 6U, 7U, 8U, 9/10U, 11/12U, 13/14U
- Costs:
 - Team Entry Fee is \$400 (paid at time of Registration)
 - Rostered Play Fee is \$25 per player (paid at Coaches Check-In on Opening Day)
- Average cost per player to participate in the KC&BO REC World Series is roughly \$60

TEAM FORMATION:

We realize that some recreational parents may not wish to extend the season and play in a World Series, so we have made allowances for that. **What is unique about the KC&BO REC World Series is that we allow Associations the ability to combine players from Rec Teams in order to make a full team for the REC World Series.** *EXAMPLE: the 7U Cubs (with 4 players) may join with the 7U Marlins (who have 5 players) and the 7U Rangers (who have 3 players), etc. The Home Association simply verifies the roster is comprised of eligible recreational players. In this example, **the teams do NOT have to buy a special jersey**, they can simply wear their regular recreational jerseys. **WE ACTUALLY ENCOURAGE wearing your leagues recreational teams' uniforms!***

Again, these are NOT the Leagues ALL STAR TEAMS! We simply want to reach as many recreational players as possible! **So, whether it is a full team or some teams that have combined to create a full team, come one, come all (eligible recreational players) to play in the KEEP CALM & BASEBALL ON - REC WORLD SERIES!**

REGISTRATION:

Team Registration and roster submissions will be handled through the use of Google Forms (not the NCS platform). We will have a publicly viewable schedule and bracket available online during the event.

- WE WILL HAVE ABOUT A 3-4 WEEK WINDOW FOR TEAMS TO REGISTER AND PAY THE ENTRY FEE IN ORDER TO PARTICIPATE IN THE KC&BO – REC WORLD SERIES.
- **A hard registration completion deadline of Friday, May 22nd, 2026**

PAYMENT:

- Since this is basically an “**invitation only/private event**” we are creating a NON-PUBLIC tournament using the KC&BO website to house most of our information, etc. It becomes public for participating teams ONLY after the official registration is completed.
- Once this information is collected, we will create a master **WHO’S COMING LIST**
- **WE WILL PROVIDE PAYMENT OPTIONS SOON.** The ENTRY FEE is \$400, and is DUE PRIOR TO FRIDAY, MAY 22nd, 2026 *{The Rostered Play Fee (\$25 per player) is not due until Team Check-In on Friday, May 29th.}*

ALL TEAMS WANTING TO PARTICIPATE MUST BE REGISTERED AND PAID NO LATER THAN MAY 22nd (Don’t delay. Pre-Register EARLY)

ROSTER BUILDING:

- The coach also adds/builds his team ROSTER via a provided document (all rosters **MUST** be approved by your home league, as per guidelines provided, prior to submitting to KC&BO).
 - Rosters need to be approved by each league (*double sign-off*) before they are sent to us. This is incumbent on the Head Coach and the Home League Representative.
 - Approved Rosters are then submitted to KC&BO.
- Once rosters are approved/submitted, and the entry fee is paid, the team is officially “IN” and is now eligible to be scheduled!
- There are STRICT deadlines: Registration, Building and Submitting the Team Rosters, and Payment of the Entry Fee. *(WE MUST FULLY CLOSE REGISTRATION BY MAY 22nd, 2026 in order to be able to schedule the event).*

COMMUNICATION:

- Email will be our primary form of Communication (field status, sponsor info, etc.)
- The KC&BO Website will house all tournament information
- Once all teams are officially accepted to the KC&BO – REC World Series, we will be using email for all tournament communication to Coaches.
 - Coaches will in turn communicate with their families!

RULES:

- We worked hard again last year with all leagues to come up with a standard set of rules. That worked out pretty well (thank you to all involved with rule creation)!
